Topic: In this presentation, Mr. Gordon will discuss the legislative efforts to incorporate the Delta Vision and Bay Delta Conservation Plan with The Public Policy Institute of California, including recommendations to protect and restore the Sacramento-San Joaquin Delta.

Speaker Biography: Mr. Alan Gordon has been working on environmental issues in the state of California since 1987. Mr. Gordon has been Principal Consultant to the Senate Select Committee on Coastal Protection and Watershed Conservation since he joined the Capitol Office in 2005. Mr. Gordon's job involves legislative efforts incorporating science, funding, and governance reform to effectively restore the Sacramento-San Joaquin Delta estuary and water delivery system. Previously, he was a consultant to the Senate Toxics Committee and Senate Insurance Committee, and worked as an environmental consultant to then President Pro-Tem Bill Lockyer. He also served as Deputy Director of the Department of Toxic Substances Control under Governor Gray Davis. In addition, Mr. Gordon is an adjunct faculty member in the Department of Political Science-Environmental Policy at UC Davis.

Mr. Gordon earned a JD from Golden Gate University School of Law, in addition to attending Emory University earning both a MA in Political Science as well as a BA in Political Science and History. He also holds an Honorary Degree in History from University College (Oxford University).
